We have received your public records request sent in via our website, as follows:

Greetings to THE STATE OF WASHINGTON, I am writing you today in regards to ANY AND ALL public records from ANY and ALL agencies regarding the following;

- 1) Copies of the ACTUAL ACCOUNTING whereby your PERSON (THE STATE OF WASHINGTON) has incurred a loss DUE TO ANY alleged debt from the actions of the medical cannabis industry;***
- 2) BILLS (not a statements) for any amount of money allegedly owed to your PERSON (THE STATE OF WASHINGTON) by the medical cannabis community;***
- 3) Proof your PERSON (THE STATE OF WASHINGTON) is operating with proper business licensing both state and federal;***
- 4) Proof of any LEGISLATIVE ACTION (i.e. STATE AND FEDERAL Session Law, and corresponding R.C.W/W.A.C. and/or U.C.C./U.S.C.) allowing the sales and/or taxing and/or distribution of cannabis and/or marijuana;***
- 5) Proof the contribution of consideration for and/or to medical cannabis is a taxable event and corresponding contract;***
- 6) Proof of any LEGISLATIVE ACTION (i.e. STATE AND FEDERAL Session Law, and corresponding R.C.W/W.A.C. and/or U.C.C./U.S.C.) allowing your PERSON'S (THE STATE OF WASHINGTON) policies to superseded law and due process;***
- 7) Proof your PERSON is NOT applying an erroneous tax;***
- 8) Proof donations, contributions, and/or gifting are taxable events;***
- 9) Proof of any lawful Judgment(s) and/or Order(s) from your PERSON (STATE OF WASHINGTON) are enforceable, have merit, and are under an established lawful JURISDICTION;***
- 10) Proof that there is any lawful money in circulation, backed by anything of value with which to pay, along with the agreed specification of the unit of measure;***
- 11) Proof all human beings are not governed by consent and are not sovereign, only able to be dictated to and coursed into onside contractual obligations;***
- 12) Proof of any LEGISLATIVE ACTION (i.e. STATE AND FEDERAL Session Law, and corresponding R.C.W/W.A.C. and/or U.C.C./U.S.C.) granting sovereignty to your PERSON (THE STATE OF WASHINGTON), immunity to due process and collateral attacks;***
- 13) Proof of any LEGISLATIVE ACTION (i.e. STATE AND FEDERAL***

Session Law, and corresponding R.C.W/W.A.C. and/or U.C.C./U.S.C. and/or verbiage within TITLE 66: ALCOHOLIC BEVERAGES) granting and entitling the WASHINGTON STATE LIQUOR CONTROL BOARD with the power to regulate cannabis.

Please consider this correspondence as my formal NOTICE OF REQUEST FOR PUBLIC RECORDS in accordance with the PUBLIC RECORDS ACT, RCW chapter 42.56, regarding "THE CITY OF YELM"

- 2) any and all details regarding residential water meters (i.e. purchase price, funding for said purchase, date of purchase, agent in charge of said purchase, and income from rental fees of said meters) for "THE CITY OF YELM"**
- 3) any and all relevant information with regards to "THE CITY OF YELM" municipal water supply and meter rentals I wish to receive the information via digital format.**
